### MISSISSIPPI BAND OF CHOCTAW INDIANS

SEALED BIDS for the construction of **IMPROVEMENTS TO BIA ROUTE NOS. 2242/0222 (INDUSTRIAL DRIVE/ROAD)** will be received by the Mississippi Band of Choctaw Indians at the Public Works office, 258 Industrial Road, Choctaw, Mississippi 39350, Telephone: 601-650-9422 in the PEARL RIVER COMMUNITY, Choctaw, Mississippi until **10:00 am**, Local Time, **October 23, 2020**, at which time and place, the Bids will be opened and read aloud.

If the amount of a Bid is equal to or greater than \$50,000, Bidder shall hold a current Certificate of Responsibility for Highway Street and Bridge Construction as issued by the Mississippi State Board of Public Contractors.

The major items of work consist of: mobilization, maintenance of traffic, minor base repair, approximately 62,000 square yards of milling, 7,200 tons of hot mix asphalt overlay, and striping of approximately 2.9 miles of Industrial Drive.

Bids shall be accompanied by Bid Security in the form of a Bid Bond, certified check, or cashier's check in an amount equal to five percent (5%) of the Bid made payable to the Mississippi Band of Choctaw Indians. The Mississippi Band of Choctaw Indians reserves the right to reject any and all Bids; to waive any and all informalities not involving price, time, or changes in the work; to negotiate contract terms with the Successful Bidder; to disregard any Bid which it deems to be non-conforming, irresponsible, non-responsive, unbalanced or conditional; to hold all Bids for examination for a period of up to sixty (60) days after their opening; and to award a contract to the Bidder whose Bid, after evaluation pursuant to all applicable requirements of the Bidding Documents, is considered to be the one which is in the best interest of the Mississippi Band of Choctaw Indians.
