1. On Page SI-1, 8 mph has been changed to up to 8 mph under section labeled Performance, subsection Max Speed (Unloaded).

E. Responses to Questions:

1. Question: The max speed of the Taylor Dunn TT316AC is only 6 MPH not 8 MPH as noted in the Site Inspection Certificate on page SI-1 under Performance. Is the 6 MPH acceptable?

Response: Yes.

2. Question: Is the 16,000# tow capacity a requirement or are lower tow capacities acceptable?

Response: No, tow capacities lower than 16,000 pounds are not acceptable.

3. Question: What will these units be towing? To require 16,000# towing capacity

Response: The carts will be towing up to eight (8) food carts.
