They will be publicly opened via virtual meeting and read aloud at 1:00 p.m. All bids received after ~~12:30~~ **12:00** p.m. will not be considered. Bids must be accompanied by a bid deposit of 2% of the total amount bid in the form of a certified check or bidder's corporate surety bond made payable to Special School District No. 1.

Electronic submission must bear the name of the firm submitting the bid, the Official Publication Number OP 21-2109, and the Official Publication Title "Multi-Site PA and Clock Replacement (Phase 2)".
