Deer Valley Airport (DVT) Food and Beverage Concession

1. CLARIFICATION:

Aviation Revenue Contract Solicitation (AVN RCS 21-002) is seeking Responses from qualified Respondents to operate a full-service restaurant at Deer Valley Airport. The separate retail space in the terminal will not be offered through this RCS process.

2. DELETE AND REPLACE:

G. RESPONSE RESULTS

Due to the national COVID-19 pandemic emergency and in compliance with the Center of Disease Control and Prevention (CDC) and the Arizona Department of Health Services recommendations for health, safety, and social distancing, all Aviation Department public openings will be held via remote telephone and video access until further notice.

The opening of the Response Submittals will take place on their designated date and time through remote video and telephone conference with the link and dial-in phone number provided by the Aviation Department to the public. Responses will be opened remotely and accessible by the public at the link provided on the offer due date and time indicated in the Schedule of Events, at which time the name of each Respondent will be made available. The City will post the Respondent's name on the City's website, <https://solicitations.phoenix.gov/Awards> within five calendar days of the response opening. Responses are not available for public inspection until after the City has posted the award recommendation on the City's website. Once the City has reviewed the responses, the City will post an award recommendation on the website. The City will not provide any further notification to unsuccessful Offerors or Respondents.
