Sealed Bids: Sealed Bids for the construction of the **Berrien County - FY 21 OSS LMIG** will be received, by **Berrien County Board of Commissioners**, at the **Berrien County Courthouse, 201 N. Davis Street, Room 198, Nashville, GA 31639**, until **11:00 A.M., Thursday, August 19, 2021** local time, at which time the Bids received will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

Contractor License: Any Contractor submitting a bid must be a pre-qualified Georgia Department of Transportation Contractor. License numbers must be written on the face of the bid envelope. No bid will be opened unless the license number is clearly shown. See Instructions to Bidders for additional bidding requirements.

Work to Be Done: The work to be done shall consist of furnishing all labor, materials and equipment necessary to construct the proposed **Berrien County - FY 21 OSS LMIG** as described in the Contract Documents and Specifications. In general, construction consists of thermoplastic striping and raised pavement markers for approximately 11.0 miles of roadway and all associated measures for the complete project. This work will be awarded in one (1) contract with a **180-consecutive** calendar day construction schedule.

The successful bidder, if awarded the Contract, will be required to furnish a Performance Bond and Payment Bond, each in the amount of one hundred percent (100%) of the Contract amount. All bonds must appear on the Treasury Department's most current Circular 570 Listing.
