Notes:

The City of Farmington Utility System (FEUS) is seeking bids for the civil work associated with the expansion and improvement to the Bergin Substation. The civil work expansion and improvements will include the following items:

- 1) Expand the existing substation yard approximately 25.0' to the west. Work includes topsoil removal, cut and fill earthwork and placement of erosion control material, for the west yard expansion only.
  
- 2) Construction of trapezoidal shaped, filter fabric and riprap lined drainage channels on the east and west sides of the existing substation yard. East channel extends from new diversion dike south to the outfall. West channel to extend from new HDPE pipe culvert southeast to existing drainage ditch.
  
- 3) Installation of approximately 133 linear feet of 24" HDPE pipe and two (2) Agri Drain stainless steel rat guard at each end.
  
- 4) Construction of approximately 441 linear feet of rectangular shaped open concrete drainage channel along the north side of the substation yard with a concrete headwall interfacing with the northeast end of the 24" HDPE pipe.
  
- 5) Installation of wire wrapped rip-rap slope stabilization materials along the north and east sides of the substation.
  
- 6) Construction of approximately 91.0 lineal feet of trapezoidal shaped concrete diversion dike structure and V-shaped swale along the east side of the substation.
  
- 7) Installation of (1)20.0' vehicle gate, (2)3.0' panic gates, and approximately (23) new fence posts 20.0' to the west of the existing west substation fence. No fence fabric, barbed wire, top & bottom rails or braces to be installed on new fence posts to the west of the existing substation at this time.

8) Installation of approximately 860.0 lineal feet of new security fence along the north & east sides of the substation and (2) 10.0' long isolation fence sections. Includes fence fabric, barbed wire, top & bottom rails, braces, etc. for a complete fence system. Also includes installation of (1) 14.0' vehicle gate and (1) 3.0' panic gate.

9) Excludes work to existing ground grid. Should the existing ground grid be exposed and/or damaged during construction contractor shall contact FEUS immediately.

10) Excludes any civil work within the existing substation fence.

**Contractor's Safety Certification**

The Contractor named below hereby certifies and shall comply with all applicable Federal, State, County laws, rules, regulations, City ordinances, and best safety practice guidelines for the health and safety of contractor and sub-contractor employees when performing work for the City of Farmington. The City of Farmington Compliance Contractor Safety Verification Program shall require contractors and subcontractors to comply with the law, and use all safety precautions to protect their employees, and the public when engaged in construction projects. BASIS: It is the responsibility of the general contractor to ensure contractor, and sub-contractors working within the City of Farmington adhere to all applicable safety, health, and environmental standards while conducting business on the construction site or on City Property. When a general contractor arranges to have employees of another employer (sub-contractors) perform work that involves activities that may put personnel at risk, the general contractor will inform the sub-contractor that the workplace contains specific hazards and that the work to be done shall be allowed only if all workers have the proper training, necessary certification(s), proper equipment, and work conditions to complete the work safely.

GENERAL: The contractor will ensure that safe work practices are used by contractor and sub-contractor personnel to provide for the control of risks associated with hazards, by using established procedures for; lock-out-tag-out, confined space entry, welding, trenching, piping, PPE, fall protection, dust control, hearing protection, public safety, and general safety. At the request of the City's Safety Division, the contractor shall provide information regarding the contractor's past safety performance and current safety program.

Responsibility: The contractor shall be responsible for complying with the safety standards applicable to the work they are performing. The contractor agrees that he/she is responsible to enforce compliance with all safety regulations from everyone, including sub-contractors, who work on the contract as a condition of employment on the contract.

Contractor Safety Inspections: Contractor work site safety inspections may be conducted periodically by a City of Farmington Safety Inspector.

**3** **Drug-Free Workplace Certification**

The Contractor named below hereby certifies to be in compliance with 49 CFR parts 40 and 382 by establishing a program designed to help prevent accidents and injuries resulting from the misuse of alcohol or use of controlled substances by drivers of commercial motor vehicles and to provide a workplace free of drug use and alcohol misuse.

6. That no one who has tested positive within the past year will be allowed to perform work on this project.
